## Background :

The International Association of Nurses believes that nurses, as part of the healthcare professionals, can consider injecting determinants of health, including social, economic, cultural and political, into health systems in the hope of achieving people-centred health services. Nurses around the globe advocate for shared health in the most challenging and resource-limited environment; advise policy-makers on appropriate health service solutions based on the experience closest to patients; and improving everyone's health through a refocusing on health promotion and disease prevention.

To establish an exchange platform for Nursing Associations across the Cross Strait, Hong Kong and Macao, the Chinese Nurse Association initiated organizing the "Cross-Strait, Hong Kong and Macao Nursing Summit Forum" with the partnership of the College of Nursing, Hong Kong, the Macao Nurse Association, and the Taiwan Nurses Association since 2014. Each year, it has become an important event for the four Nurse Associations. In December this year, the College of Nursing, Hong Kong will host the 6th Cross-Strait, Hong Kong and Macao Nursing Summit Forum, with the theme of "Our Nurses, Our Future". Leaders and guests from overseas, the Cross-Strait, Hong Kong and Macao Nurse Associations will be invited to join this important event.

We sincerely invite nurses to actively submit papers and share their experience and professional knowledge. Through mutual learning, we hope nurses help promoting sustainable healthcare, enhancing nursing quality, as well as advocacy of healthy lifestyle.

## Abstract submission requirements and criteria

1. An abstract, in a length within 500 words;
2. Should select a covering sub-theme of the abstract;
3. Following the submission of the abstract, the Scientific Committee decided on the following presentation,
  - 3.1 摘要提交要求: Presentation will be grouped by sub-themes.
  - 3.2 摘要提交: A visual presentation of research with an academic or professional focus by an individual or representative of the research team for display.
4. The layout of submission should be in the order of the following subheadings:  
Background/Purpose,  
Method,  
Results/Findings,  
Conclusion/Discussion;
5. Abstract should be submitted either in Chinese or in English;
6. Author should provide the topic title, name of authors (the contact email address of the presenting author), working organization and unit;
7. The use of tables, graphs or images is not allowed in abstract;
8. The article should bear originality, be scientific, practical, and relevant;
9. Be precise, concise and coherent;
10. Number of abstracts submitted are not limited.
11. The participant submitting the abstract **MUST** provide one presenting author. The presenting author of an accepted abstract (oral and poster) must register within one week after receiving acceptance notification to have his/her abstract included in the final program.

## Call for Abstracts :

Abstracts must be submitted using the online abstract form via CNHK website link (<https://conference.cnhk.org.hk>) or scan below QR code. Submissions via email or facsimile will not be considered. An auto-reply acknowledgement will be received upon successful submission.

## Review of Abstracts :

All abstracts will be reviewed by the Scientific Committee of the Organizer. The result will be sent to the presenting author if there are more than one authors on or before 31 August 2023 ..
